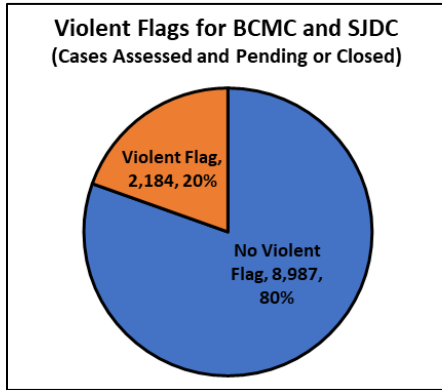
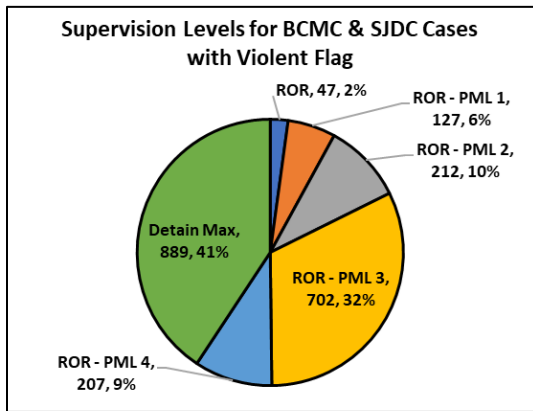


Priority 2: Red flag charges. I believe this was started.

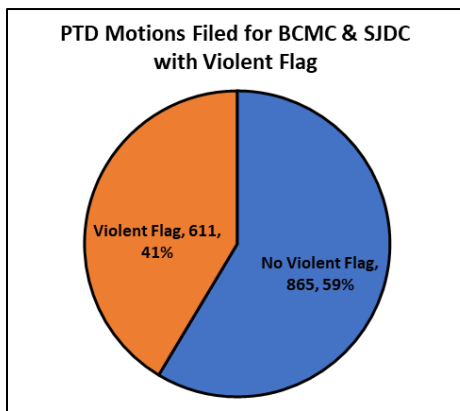
Approximately one in five cases assessed had a violent flag.



The majority of cases with a violent flag were either ROR with PML 3 (702 or 32%) or had a recommendation of detain or release with max conditions (889 or 41%).

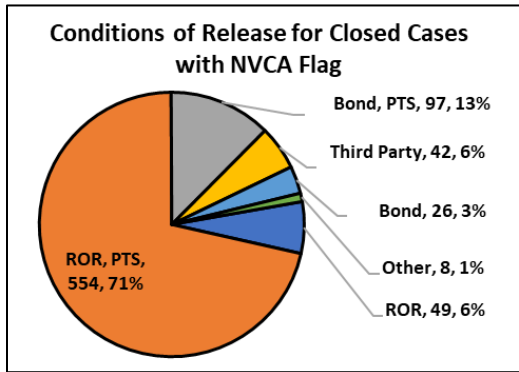


Approximately 41% of cases with a PTD motion had a violent flag.

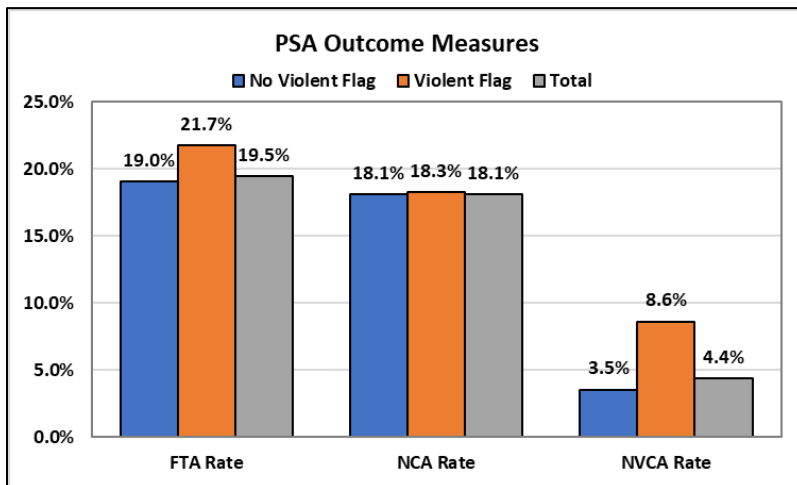


There were 1,784 closed cases with a violent flag. The release rate for these cases was 55.2% (985 out of 1,784). The release rate for cases without a violent flag was 68.0%.

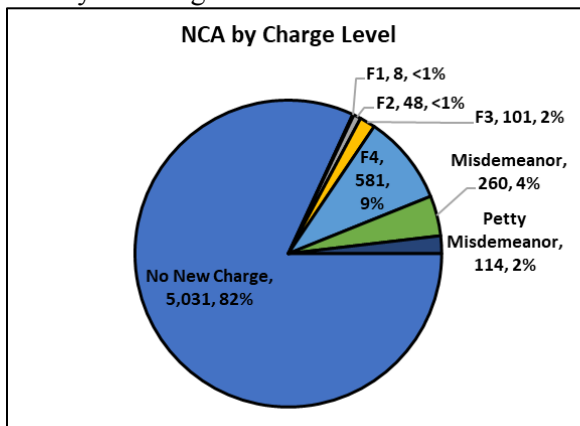
Of the 985 closed cases with a violent flag, there were 776 with conditions of release and no PTD.



The NCA rate was nearly identical between those cases with no violent flag and a violent flag although the NVCA rate was over twice as high. This indicates that while there may be an approximately equivalent rate between these groups, it is more likely to be violent.



While the bulk of cases had no NCA during the pretrial time period, the majority of the new criminal activity is 4th degree felonies or misdemeanors.



There are five factors on the PSA that contribute to the NVCA score: current violent offense (0 or 2 points), current violent offense and 20 years old or younger (0 or 1 points), pending charge (0 or 1 points), prior conviction (0 or 1 points), and the number of prior violent conviction (0, 1, or 2 points). The total possible points range from 0 to a total of 7 and those with 3 or less total points do not have a violent flag and those with 4 or more have a violent flag. Out of the five factors on the PSA, a current violent offense and prior violent convictions have the largest potential impact on the total score.

Currently the categories for SJDC cases are not available. However, this information is available for BCMC cases. For closed BCMC cases the rate of cases with the violent flag, there are six categories of charges that have higher NCA rates than others. The offenses for the assessed cases were broadly categorized into 17 offense categories. Of these, 6 had an NCA rate of 22.9% or more. Among violent offenses, the highest NCA rates were for armed robbery offenses (29.0%) and robbery (22.9%). Property offenses included several categories with high NCA rate, in particular burglary (30.6%), larceny (29.1%), and motor vehicle theft (26.2%). Finally, weapons charges had an NCA rate of 29.4%.

In these six categories with high NCA rates, the percent of cases with a violent flag varies a great deal. For armed robbery cases, just over half (50.7%) had a violent flag and for robbery cases there were 41.7% with a violent flag.

Among the remaining cases with property and weapons charges and high NCA rates, the portion of cases with a violent flag was much lower, at 2.2% or less for motor vehicle theft, larceny, and burglary and 5.9% for weapons.

The overall NCA rate is nearly identical for cases with and without a violent flag. There were more violent new crimes among those with an violent flag than those without the flag.
