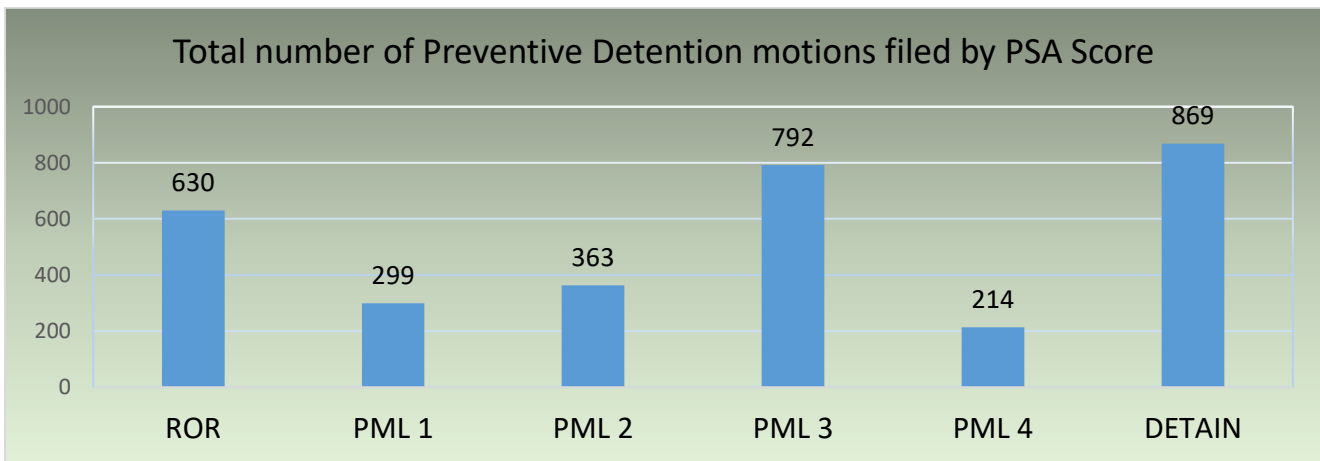




**Second Judicial District Court

Preventive Detention Statistics**

Cases in this data set include:

- ▶ Cases in which a Preventive Detention motion was filed between June 12, 2017 and January 31, 2020; and that
 - ▶ A Public Safety Assessment (PSA) was completed.
- ❖ 3,167 Preventive Detention Cases filed with a PSA Score
- Average of 4.46 days from date a motion was filed to the date of hearing.
 - All Pretrial Services recommendations to the Court are concurrent with the PSA score as Pretrial Services recommendations do not deviate from the tool’s recommendation.

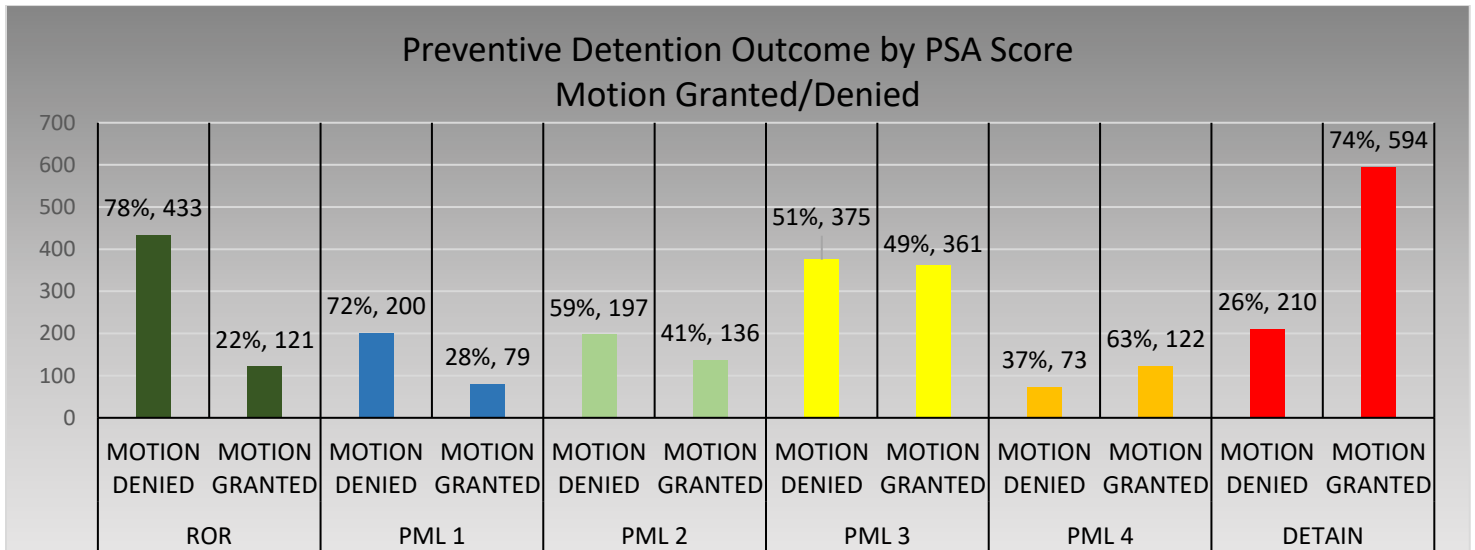


- Preventive Detention Motion Outcomes: The following data only includes outcome for the initial Preventive Detention hearing in a LR District Court Case (the underlying case is pending in Metropolitan Court). These numbers do not include the ultimate outcome of a case or what happened after the initial detention hearing, whether it be the LR or CR District Court case.

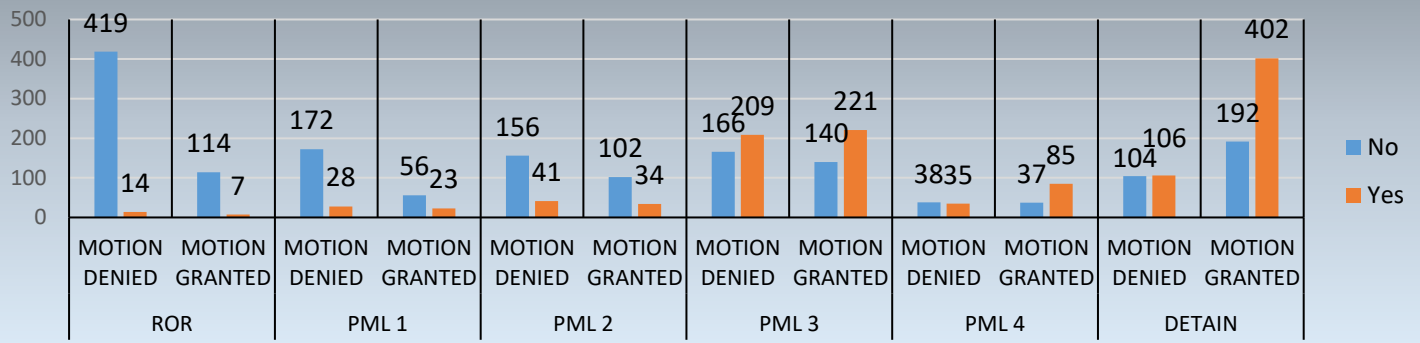

- ❖ 2,901 Preventive Detention Cases with PSA Score and Motion Outcome that = (Granted/Denied)
 - Granted – 1,413 (48.71%)
 - Denied – 1,488 (51.29%)



- ❖ Preventive Detention Hearing Outcome with Violence Flag:
 - The Violence Flag was present in 1,205 (41.54%) of cases in which a Preventive Detention Motion was filed.
 - Granted – 772 (64.07%)
 - Denied – 433 (35.93%)
 - The Violence Flag was **NOT** present in 1,696 (58.46%) of cases in which a Preventive Detention Motion was filed.
 - Granted – 641 (37.79%)
 - Denied – 1055 (62.21%)

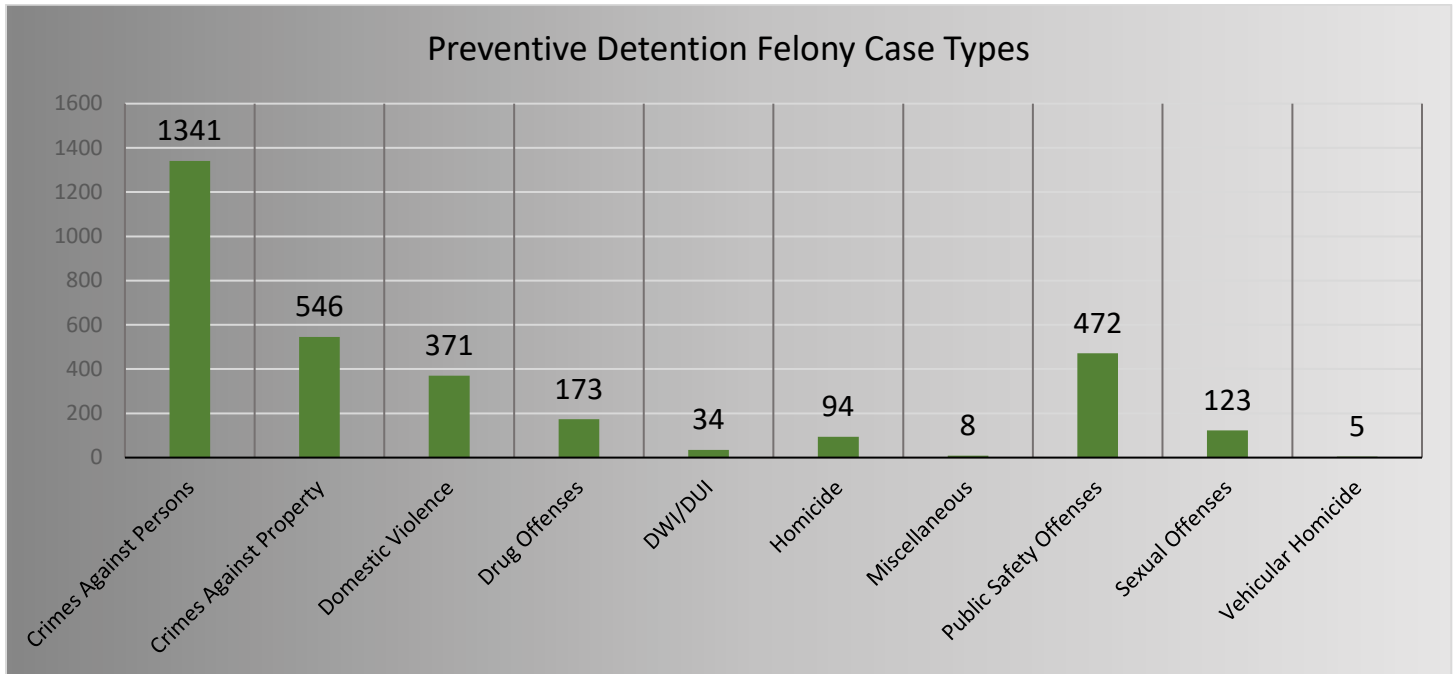
Preventive Detention Outcome - Denied/Granted by PSA Score with Violence Flag - Yes/No
