8. Within the past 14 days, have you had a fever at or above 100.4 degrees, chills, sore throat, body aches, congestion or runny nose, nausea or vomiting, diarrhea, headaches?
 - Yes - *You are not permitted to enter the building*

9. Within the past 14 days, have you developed new shortness of breath, difficulty breathing, or dry cough?
 - Yes - *You are not permitted to enter the building*

10. Have you recently developed a loss of taste or smell?
 - Yes - *You are not permitted to enter the building*
