



New Mexico Judicial Branch COVID-19 Court Facility Screening Questions
Employee – NOT Fully Vaccinated

A judicial officer or employee is considered fully vaccinated when they are two weeks beyond their second Moderna or Pfizer vaccination, or their first Johnson and Johnson vaccination as confirmed by submission or presentation of the judicial officer's or employee's vaccine card to human resources.

1. What is your work status today?
 - Teleworking
 - Working in the building
 - On leave – Please give the dates you will be on leave _____

2. Have you tested negative in the past seven (7) days?
 - Yes - *Please proceed to question #3*
 - No - *You are not permitted to enter the building*

3. Within the past 10 days, have you traveled outside of the United States?
 - Yes - *You are not permitted to enter the building*
 - Yes – *You have self-isolated for 7 days, received a negative test result on the 5th day after returning, and no symptoms. Proceed to question #4*
 - No - *Please proceed to question #4*

4. Within the past 10 days, have you traveled to another state? (If you reside outside of New Mexico or traveled for essential medical care outside of New Mexico, have left the State for less than twenty-four hours for matters attendant to parenting responsibilities, please answer “other”)
 - Yes - *You are not permitted to enter the building*
 - Yes – *You have self-isolated for 7 days, received a negative test result on the 5th day after returning, and no symptoms. Proceed to question #4*
 - No – *Proceed to question #4*
 - Other (notify your supervisor)

5. Have you been asked to self-quarantine because of COVID-19 and are you still within the quarantine period?
 - Yes - *You are not permitted to enter the building*
 - No

6. Within the past 14 days, have you been diagnosed with COVID-19 by a doctor or received positive test results for COVID-19 from a testing center or by the Department of Health?
- Yes- *You are not permitted to enter the building*
 - Yes, *but I have been advised by New Mexico Department of Health that I may return to activities*
 - No
7. Have you taken a COVID-19 test due to travel, potential contact, or COVID-19 symptoms, and are still waiting for the test results?
- Yes - *You are not permitted to enter the building*
 - Yes - *You have already completed a ten (10) day self-isolation period, AND you have the approval of your administrative authority. Proceed to the next question.*
 - No
8. In the past 10 days, have you been in contact with anyone who you know has COVID-19, or with someone who has traveled to New Mexico from another state or country?
- Yes - *You are not permitted to enter the building*
 - No – *Proceed to question #9*
 - Yes – *I had contact with someone who arrived from out-of-state have self-isolated for 7 days, received a negative test result on the 5th day after returning, and no symptoms. Proceed to question #9*
 - Yes - *I had contact with a household member and self-isolated for 14 days*
9. Within the past 14 days, have you had a fever at or above 100.4 degrees, chills, sore throat, body aches, congestion or runny nose, nausea or vomiting, diarrhea, or headaches, or developed new shortness of breath, difficulty breathing, dry cough, or loss of taste or smell?
- Yes - *You are not permitted to enter the building*
 - No
 - Other - *You have received a negative COVID-19 test result while asymptomatic, self isolated for at least ten (10) days **and** have been symptom free for 72 hours, **OR** you have a negative COVID-19 test result while symptomatic and have been symptom free for 72 hours or a medical verification of a chronic illness or condition, and your chief judge or designee approval. Proceed to the next question.*
